1 PLEASE TAKE NOTICE that the City of Stockton, California (the “City”), the debtor in
 2 the above-captioned case, has scheduled a hearing on June 12, 2013, at 3:00 p.m. before United
 3 States Bankruptcy Judge Christopher M. Klein in Courtroom 35, located on the 6th floor of the
 4 United States Courthouse, 501 I Street, Sacramento, California, 95814, on the City’s Motion For
 5 Order Shortening Notice On Motion For Order (1) Fixing August 16, 2013 Bar Date For All
 6 Claims Other Than Claims Based On Retiree Health Benefits, (2) Approving Form Of Notice Of
 7 Bar Date And (3) Requiring City To Publish And Transmit Notice Of Bar Date To Creditors And
 8 Parties In Interest By No Later Than June 28, 2013 (the “Motion”). The Motion seeks an order
 9 shortening notice on the hearing on the City’s Motion For Order (1) Fixing August 16, 2013 Bar
 10 Date For All Claims Other Than Claims Based On Retiree Health Benefits, (2) Approving Form
 11 Of Notice Of Bar Date And (3) Requiring City To Publish And Transmit Notice Of Bar Date To
 12 Creditors And Parties In Interest By No Later Than June 28, 2013 (the “Bar Date Motion”). The
 13 Bar Date Motion seeks an order: (1) setting August 16, 2013 as the date by which proofs of claim
 14 may be filed against the City; (2) approving the form of “Notice Of August 16, 2013 Bar Date”
 15 (“Bar Notice”), a copy of which is attached as Exhibit 1 to the Bar Date Motion; and (3) requiring
 16 the City to publish the Bar Notice in *The Stockton Record* and to transmit the Bar Notice to all
 17 creditors and parties in interest by no later than June 28, 2013.

18 PLEASE TAKE FURTHER NOTICE that in accordance with Local Bankruptcy Rule
 19 9014-1(f)(2), parties-in-interest are not required to file written opposition to the Motion.
 20 Opposition, if any, shall be presented at the hearing on the Motion.
